- 1) **Introductions and Determine Quorum:** Andrew began the meeting with the land acknowledgment and introductions. A quorum was established.
- 2) **February 6th Agenda:** The February agenda was approved.
- 3) **January Meeting Summary:** The January meeting summary was approved.
- 4) **Community Updates:**
  - Ellen O'Toole shared information about an organized beach cleanup scheduled for Sunday, February 16 from 1-3 at Marine Park, Blaine. The GSSC is looking for volunteers to help with intertidal species ID on Sunday, March 2, 12-1:30pm at Birch Bay State Park.
  - Don Hunger extended an invitation to the Northwest Straits Foundation Scholars Reception, March 29, at the Padilla Bay Reserve. The Caroline Gibson Scholars will be presenting their research application to Salish Sea conservation and stewardship.
  - The NWSF will be hosting a spring celebration at Larrabee State Park, to celebrate collaboration with the MRCs – particularly Whatcom and the eelgrass work at Wildcat Cove.
- 5) **NWSF Partnerships Update:** Don Hunger described the NWSF, and ways they can support the MRCs and their projects. 2025 grant prospects were shared. The NWSF accepts project support funding requests from MRCs year-round. The ability to support requests depends on corporate, foundation, and donor support. A project funding request form is available.
- 6) **Whatcom 2025 Comp Plan Update:** Lauren Clemens, Climate Action Manager, Whatcom County Public Works, explained that the Washington State Growth Management Act (GMA) requires Whatcom County to review and revise its comprehensive plan and development regulations by December 31, 2025. One change in the GMA that affects the 2025 update is the addition of a climate change/planning element. A draft of the climate chapter was included in the MRC meeting packet. Lauren encouraged the committee to review the draft chapter and provide feedback, particularly on policies related to marine resources. It is preferred that comments be submitted by March 20. The chapter will be in the MRC's google drive for members to make comments/edits. The MRC can make a formal motion to accept/ recommend revisions at the March 6 meeting. Documentation of reasoning and focusing comments on specific policies, is encouraged.
- 7) **Stormwater System Redesign:** Alice Cords, Port of Bellingham (POB), described the POB stormwater program. The Phase II Municipal Stormwater Permit and the Port Industrial Stormwater General Permit were detailed along with the Port's implementation of those permits. Alice described stormwater redevelopment and improvement sites within Bellingham. The Port is active in Green Marine, in which continuous improvements are required to keep that certification. Port re-development areas that are connected to the ASB will require stormwater treatment prior to the ASB going offline, which is planned several years in the future. Re-development work is based around how the stormwater will be managed.
- 8) **MRC Partner Committee Updates**
  - **County Council:** Kaylee mentioned that the County is working to reconcile budget challenges. A lot of work is being put into the Comprehensive Plan updated. In terms of federal funding, having a clear

understanding of the risks/impacts of losing federal dollars, and establishing back up plans is an important proactive step.

- **Port of Bellingham:** No report

- **NWSC:** Mike MacKay shared recognition of Nan MacKay, gubernatorial appointee to the Commission. The federal authorization for continuous funding was not accepted this year. The Science Advisory Committee is scheduling a forum for October 2025.
- **BB Action Team:** A table with updates on the waterfront redevelopment was shared in the meeting packet.

**9) Staff and Committee Updates:** Draft documents describing MRC member and staff expectations were shared in the meeting packet with the intent to get committee approval to include in the MRCs Policies and Procedures Manual. A quorum was no longer present, so action item was tabled. The marked-up version of Chapter 10: Environment, and the draft Climate Chapter of the comp plan will be placed in the MRC google drive for members to review and comment. The MRC will host a booth at SeaFeast this year.
